Delegation from Algoma Power Inc. Peggy Lund and Andrea Mattioli addressed Council. They spoke about Heating and Cooling incentives to be found on www.saveonenergy.ca. Coupon Programs that expire on September 30, 2017, found at www.algomapower.com. Instant Savings Programs coming this spring to be announced. Pre approved retrofit programs, Small business lighting programs and a personal funded Power Audit Program. Also discussed was the line clearing program and long range joint studies on compatible species to grow under power lines and environmentally kind insecticides and pesticides.

Roads Report: Gravel costs have increased a small amount this year. Roads tour was completed by Council and Roads Staff and the consensus is the roads are generally in excellent condition. Patching is on going and the sweeping of winter sand off the roads at intersections has been completed. Council asked that a letter be sent to the Roads Association asking why MSO was not asked to submit a tender for hard surfacing. Staff will continue to prepare for budget meetings by pricing out maintenance and capital projects.

Clerks Report: Staff will conduct student interviews; council has approved the hiring of two students. Septic system has required some work here at the office. We have had a student, doing volunteer hours picking up garbage along the roads, thank you Caleb.
