WHEREAS a healthy Bee population is necessary for healthy and sustainable food production, and;

WHEREAS the health of the Bee population must take precedence over profits, and; WHEREAS the Bee population in Canada and World Wide is in a critical state; THEREFORE every effort must be made with the utmost haste to protect the Bee population. (Cd)

WHEREAS the critical condition of the Bee population in Canada and World wide will soon drastically impact the food production in Canada and the rest of the World. All necessary measures must be taken immediately to protect the Bee population and reverse the decline and potential extinction of the Bee population and avoid the devastating impact the loss of a healthy Bee population will have on food production world wide.
