

By - Law

# BEING A BY-LAW TO REGULATE ENTRANCE-WAY CULVERT INSTALLATION AND REPLACEMENT.

WHEREAS the Council of The Corporation of The Township of Tarbutt has deemed it necessary to regulate the installation and replacement of all new and existing entrance-way culverts under the jurisdiction of the Corporation;

**AND WHEREAS** Section 27 (1) of the Municipal Act, 2001, S.O. 2001, c. 25 provides that a Municipality may pass by-laws in respect of a highway if it has jurisdiction over the highway.

**NOW THEREFORE** The Corporation of The Township of Tarbutt pursuant to the provisions of the Municipal Act enacts as follows:

- THAT an entrance-way, for the purpose of this by-law, is any driveway, laneway, private road, entrance or other structure or facility constructed or used as a means to a Township road and includes the tiling and covering of a roadside ditch for the purpose of improving a lawn or other frontage.
- THAT no entrance, culvert, bridge or access from a Township road, over any
  ditch or watercourse or adjacent to any Township road may be constructed
  without approval by the Road Superintendent or his/her designate or Engineer
  employed by the Township.
- 3. **THAT** no person (s) shall obstruct a ditch, culvert or watercourse upon a highway or any drain or watercourse within the Township of Tarbutt.
- 4. THAT the location of the entrance must be approved by the Road Superintendent or his/her designate or Engineer employed by the Township, to ensure public safety and convenience and to provide favourable sight lines, grade and alignment for all traffic using the proposed access and roadway; no undue interference with the safe movement of traffic and will not adversely affect other properties.
- 5. **THAT** for the purpose of this by-law, culvert and pipe will have the same meaning and intent.
- 6. **THAT** the diameter, gauge, length and type of culvert to be used shall be determined by the Road Superintendent or his/her designate or Engineer

- employed by the Township; and that the completed entrance-way shall maintain a safe approach compatible to the grade level of the road surface.
- 7. **THAT** where an entrance is being established for the first time, to permit access from the Township road and is not a subsequent entrance or the replacement of a prior entrance the Township shall supply the first entrance-way culvert/pipe, one length, up to twenty feet in length (20 feet) or six point zero nine six meters (6.096 meters) x a maximum of (3 feet) or 91.44 cm in diameter; and conduct the installation or oversee the installation; with the actual cost of the installation being the responsibility of the property owner.
- 8. THAT from time to time an entrance may be requested that does not constitute a 'typical' entrance, such as an entrance to a farm lot or commercial lot where the entrance needs to be greater than a single culvert length, or where a ditch is of exceptional depth where a typical culvert as described above will not be sufficient; in a case by case review Council may offer to share some additional portion of the cost of the original installation as a means of assisting in promoting development and assessment in the Township.
- 9. THAT all subsequent pipes shall be installed and/or replaced solely at the expense of the property owner and shall be located in exactly the same location and maintaining the exact same size or volume unless, prior approval to move the culvert or to resize the culvert has been received from the Road Superintendent or his/her designate or Engineer employed by the Township. Any damages to the surface of the road shall be the responsibility of the property owner.
- 10. THAT the Road Superintendent or his/her designate or Engineer employed by the Township is hereby authorized, in the event an entrance-way has been installed or improved to an unacceptable standard, or in an unsafe way, to affect such installation repairs as necessary and/or to remove the entrance-way at the property owner's expense.
- 11. **THAT** any costs in this by-law that are the responsibility of the property owner, if not paid may be collected in the same manner as taxes
- 12. THAT an entrance approval is a pre-requisite to the issuance of a Building Permit
- 13. **THAT** the size of any entrance-way (culvert) pipe, prior to installation or replacement shall be determined by the Road Superintendent or his/her designate or Engineer employed by the Township, with consideration to unrestricted water flow, seasonal fluctuations in flow and to permit sufficient cover to ensure the integrity of the culvert; and to permit an approximate, but not less than a 2:1 slope on the ends.





#### Re: Farm Property Class Tax Rate Program

**Dear Board of Directors** 

The Farm Property Class Tax Rate program was developed by the province to support agriculture in Ontario. Through this program, farmland owners receive a reduced property tax rate. Eligible farmland is taxed at no more than 25% of the municipal residential tax rate. This program is administered by Agricorp, the Municipal Property Assessment Corporation (MPAC), and municipalities with farmland assessment within their municipality.

The Assessment Roll is returned by MPAC in December of each year for the following year. It is important that the assessment roll values on the returned roll received from MPAC are accurate as these values are used as the basis for the calculation and distribution of taxes. However, we have found that the 2020 Assessment Roll as returned

by MPAC requires many adjustments in the form of Tax Incentive Adjustments (TIA) for the Farm Property Class Tax Rate Program, each of which result in taxation write-offs for the Township.

The TIAs are required to transfer properties which have become eligible for the Farm Property Class Tax Rate Program from the Residential Class back to the Farmland Class. It is our understanding that the large number of TIAs that are processed by MPAC are necessary due to the number of farm properties that have sold their property, made a change to the ownership of the property, or failed to submit paperwork to Agricorp by the required deadline.

The result is that the Assessment Roll is returned with an overstated Residential Class assessment and an understated Farmland Class assessment and when used in the determination of the Residential Tax Rate at budget time results in a rate that is less than it would otherwise be. In addition, taxation write-offs of 75% of the residential amount must be refunded. These refunds are required for the current year, and in some instances, in the prior year as well, placing a financial burden on municipalities.

While these adjustments are not new, they certainly seem to be increasing in volume in more recent years and we anticipate that they will continue to increase as baby-boomer farmer's continue to retire and sell their farmland.

In 2020 Perth South had \$34,606,000 of Farmland Class assessment transferred to Residential Class assessment. As a result of this transfer the total write-off is \$213,550.86 of which \$107,041.20 is Perth South's portion, \$66,799.27 is Perth County's portion and \$39,710.39 is the School Board's portion. While a tax write-off of \$107,041 may not seem like a large amount for many municipalities, in Perth South is it significant and would require a 3% levy increase to offset this amount.

Perth South is also concerned with the impact that these "misclassified" properties may be having on information used by other provincial departments. For example, the classification of Farmland assessment as Residential assessment negatively impacts the Ontario Municipal Partnership Fund (OMPF) calculation, specifically the Farm Area Measure, which could result in a financial loss in the form of reduced grant funding for the year. Despite the fact that there has been no development on farmland, Perth South's Farm Area Measure decreased from 91.7% to 90.8% in 2020, a decrease attributed to the transferring of property from the Farmland Class to the Residential Class. If the Farm Area Measure were to fall below 90% Perth South would incur a loss in grant funding, a loss we simply cannot afford. And should such a loss occur there does not appear to be a mechanism to allow for the correction of the OMPF allocation following the transfer of assessment back from Residential Class to Farmland Class.

It should also be recognized that the levy costs imposed on municipalities for maintenance and administration costs of conservation authorities is also impacted by this transfer of land from the Farmland Class to the Residential Class. The apportionment of costs is determined by multiplying Current Value Assessment (CVA) in the Residential Property Class by a Factor of 1 and multiplying the CVA in the Farmlands Property Class by a factor of .25. The inclusion of assessment from the Farmland Property Class in the Residential Property Class artificially increases our proportionate share of maintenance and administrative costs and represents another unreconcilable calculation for which we are financially penalized.

The current process places an administrative burden on municipalities and diverts staff time from other administrative work that we simply do not have to spare. In recent years the provincial government has been working with municipalities and other partners to improve service delivery and efficiencies. As part of their review, Managing Transformations: A Modernization Action Plan, there was a focus on strong leadership by the government to work with ministries and various partners to strengthen horizontal coordination and establish a renewed focus on improving the efficiency, productivity and outcomes of the Broader Public Sector, while at the same time delivering the most efficient Ontario Public Services possible. A similar review of the delivery of this program may be very beneficial.

Perth South understands that the province and MPAC need to ensure that each farm operation meets the requirements of the Farm Property Class Tax Rate Program, but we feel that there must be a more efficient and effective way for this to be achieved. Perth South would like to be part of the solution and suggests that all stakeholders to the Farm Property Class Tax Rate Program review the current program in an effort to find efficiencies and ultimately, a less disruptive classification process.



# THE CORPORATION OF THE TOWNSHIP OF TARBUTT ATE: 10-28-20

#### BY-LAW NO. \_26-2018

Being a By-law to adopt an Emergency Management Program and Emergency Response Plan and to meet other Requirements under the Emergency Management and Civil Protection Act

WHEREAS under the *Emergency Management and Civil Protection Act*, R.S.O. 1990, c. E.9 and Ontario Regulation 380/04 (the "Act") every municipality in the province is required to:

- Develop and implement an emergency management program, which shall consist of:
  - o an emergency plan;
  - o training programs and exercises for employees of the municipality and other persons with respect to the provision of necessary services and the procedures to be followed in emergency response and recovery activities;
  - public education on risks to public safety and on public preparedness for emergencies; and
  - o any other elements required by the standards for emergency management set under the Act or by Emergency Management Ontario;
- Designate an employee of the municipality or a member of the council as its emergency management program coordinator;
- Establish an emergency management program committee;
- Establish a municipal emergency control group;
- Establish an emergency operations centre to be used by the municipal emergency control group in an emergency; and
- Designate an employee of the municipality as its emergency information officer;

AND WHEREAS it is prudent that the emergency management program developed under the Act be in accordance with international best practices, including the five core components of emergency management; prevention, mitigation, preparedness, response and recovery;

AND WHEREAS the purpose of such a program is to help protect public safety, public health, the environment, critical infrastructure and property during an emergency and to promote economic stability and a disaster resilient community;

**NOW THEREFORE** the Council of the Corporation of the Township of Tarbutt hereby enacts as follows:

#### **Emergency Management Program**

- 1. An Emergency Management Program for the municipality will be developed and reviewed annually by the Emergency Management Program Committee consistent with and in accordance with the Act and international best practices, including the five core components of emergency management, namely: mitigation, prevention, preparedness, response and recovery, and such program shall include:
  - a. training programs and exercises for employees of the municipality and other persons with respect to the provision of necessary services and the procedures to be followed in emergency response and recovery activities;
  - b. public education on risks to public safety and on public preparedness for emergencies; and
  - c. any other elements required by the standards for emergency management set under the Act or by Emergency Management Ontario.
- 2. The Emergency Management Program shall be consistent with the objectives of protecting public safety, public health, the environment, critical infrastructure and property, and to promote economic stability and a disaster-resilient community.

#### **Emergency Response Plan**

- 1. The Emergency Response Plan, which has been developed in accordance with the requirements of the Act and international best practices, and which is attached hereto as **Schedule A** is hereby adopted (the "Plan").
- 2. The Plan shall be reviewed annually by the CEMC and the Township's Emergency Management Program Committee. The CEMC is authorized to make such administrative changes to the Plan as appropriate to keep the Plan current, such as personnel, organizational and contact information updates. Any significant revision to the body of the Plan shall be presented to Council for approval.
- 3. When an emergency exists but has not yet been declared to exist, Township employees and the Municipal Emergency Control Group may take such action under the Plan as may be required to protect property and the health, safety and welfare of the inhabitants of the Township.

#### Community Emergency Management Coordinator (known as CEMC)

- 1. On resolution by Council, an individual will be appointed as the primary Community Emergency Management Coordinator known also as "CEMC" and be responsible for the emergency management program for the Township including maintenance of the Plan, training, exercises, public education and such other duties and responsibilities as outlined in the Act.
- 2. On resolution by Council, an individual(s) will be appointed as Alternate CEMC(s) to act in place of the primary CEMC in his/her absence.
- 3. Schedule B, which is attached hereto and forms part of this By-law designates the names of the primary CEMC and Alternates.

#### Administration

- The Plan shall be made available to the public for inspection and copying at the Municipal Office, 27 Barr Rd. S. during regular business hours.
- 2. The Plan, or any amendments to the Plan, shall be submitted to the Chief, Emergency Management Ontario identified in the Act.
- 3. By-law 28-2004 is hereby repealed.



# A Project Proposal for The Women's Institute Park, Tarbutt Township for the **Great Lakes Local Action Funding**: A Brief Report for Council

#### **Key Points**

- \$1.67 Million in first round of funding
- Up to \$50,000 for individual projects to be completed by organizations including municipalities
- Deadline for application 6<sup>th</sup> November, 2:00 pm EST <u>www.ontario/GetFunding</u>
- Funding available for projects that take place at the community level which result in
  environmental improvements to the Great Lakes and/or the streams that flow into them, with
  an emphasis on shorelines and nearshore areas. Emphasis placed on projects that have social
  and/or economics co-benefits that provide opportunities for community involvement in great
  lakes restoration and /or protection and increased opportunities for people to learn about the
  value of the great lakes
- Projects to be completed by February 18, 2022
- Tarbutt Township with the Lake Huron Watershed for funding
- Funding may be awarded for up to 100% that are directly related to eligible projects
- Applicant will be required to fulfill the full project to receive funding

#### NOTE:

Municipalities and conservation authorities and their foundations must be partnered with at least one community-based organization to be eligible for funding and must provide a signed letter from the community-based organization as part of their application, which sets out the role of the community-based organization in the proposed project. Municipalities and conservation authorities' applicants require a resolution to be submitted prior to the signing of the Transfer Payment Agreement. Resolutions can be submitted after the application form.

#### Project evaluation

Application forms and supporting materials will be screened to ensure they are complete and meet the basic eligibility requirements. If an application passes the screening, it will be reviewed and ranked according to three evaluation criteria which are in the sole discretion of the ministry:

- 1. Environmental benefit to the Great Lakes and/or their tributaries (40% of total score)
- 2. Social and economic co-benefits, community involvement, collaboration and leverage (30% of total score)
- 3. Sound project design (30% of total score) please see Great Lakes Local Action Fund Guide

In its evaluation, the ministry may also consider the kinds of projects proposed, the number of grants per organization, and types of organizations applying in order to support a variety of projects and recipients across the province.

#### Funding for Women's Institute

Funding for eligible and achievable outcomes for the Women's Institute Park are identified below. This is not a comprehensive list and can be modified accordingly:

- Basic Park restoration (social and economic co-benefits 30% of total score)
  - o Picnic Tables
  - o Parking
  - o Bins and recycling options
- Environment (Environmental benefits to the Great Lakes and/or their tributaries 40% of total score)
  - o Remove Invasive species
  - o Provide native and aesthetic plantings that promote positive environmental outcomes
  - o Informative and educational signage, websites, activities that promote protection of the environment (e.a., Great Lakes water ecosystems, plastics and the environment, climate change and increasing water levels provide example of environmentally sound shoreline protection as an example for the public)
  - Community outreach Working collaboratively with community-based organizations (Kensington Conservancy, Algoma Freshwater Coalition Alliance)
  - Hands on education for young people (helping plant native species, interactive models etc.,)

It is very important to note that education, volunteers, and community are CORE to securing funding for this project.



#### Dear Head of Council

The Ministry of the Solicitor General is committed to keeping communities across Ontario safe, supported and protected. I would like to take this opportunity to share some information with your municipality regarding the anti-racism initiatives of my ministry and the Anti-Racism Directorate (ARD), the regulatory work being done to bring the *Community Safety and Policing Act, 2019,* into force, new police oversight measures, police training as it relates to de-escalation, mental health and diverse communities, mental health and addictions initiatives and investments, Community Safety and Well-Being (CSWB) Planning and police-hospital transition protocol.

#### Anti-Racism

Our government has zero tolerance for hate, racism or discrimination in all its forms. We share a responsibility to speak out and act against racism and hate and build a stronger society. Our government is committed to addressing racism and building a stronger, more inclusive province for us all.

I am proud to be the minister responsible for Ontario's Anti-Racism Directorate (ARD), which leads strategic initiatives to advance anti-racism work across government with a plan that is grounded in evidence and research. Through the ARD, the government continues to invest in community-led research, public education and awareness initiatives. This includes investments to the Canadian Mental Health Association (CMHA) Ontario to undertake research that seeks to identify key mental health issues impacting survivors of victims of homicide violence in Ontario.

#### Community Safety and Policing Act, 2019

Our government is also committed to addressing racism at a systemic level through the regulatory framework under the *Anti-Racism Act, 2017*, and through the work we are doing to bring the *Community Safety and Policing Act, 2019*, into force. As we work to develop regulations under the *Community Safety and Policing Act, 2019*, we will continue to engage racialized groups, including Black, South Asian, First Nation, Inuit and Métis organizations. We are committed to ensuring that Ontario's communities are well supported and protected by law enforcement and that all interactions between members of the public and police personnel are conducted without bias or discrimination, and in a manner that promotes public confidence and keeps our communities safe.

The Community Safety and Policing Act, 2019, which is part of the Comprehensive Ontario Police Services Act, 2019, provides policing and police oversight legislation. Once in force, the Community Safety and Policing Act, 2019, will address a number of recommendations made by Justice Michael H. Tulloch, including:

- Mandatory training for all police service board members, the Inspector General, inspectors, police officers and special constables on human rights, systemic racism as well as training that promotes the diverse, multiracial and multicultural character of Ontario society and the rights and cultures of First Nation, Inuit and Métis Peoples;
- The requirement for each municipality that maintains a municipal board to prepare and publish a diversity plan to ensure members of the board are representative of the diversity of the population of the municipality;
- Not releasing the names of officials and witnesses in SIU investigations;
- Ensuring information made available to the public about an SIU investigation helps them understand the decision made by the SIU director; and
- Ensuring the SIU continues to publish investigative reports on its website.

#### New Measures for Police Oversight

#### Inspector General of Policing

The Community Safety and Policing Act, 2019, will establish an Inspector General (IG) of Policing who will be required to monitor and conduct inspections related to compliance with the Act and regulations. The IG will work with policing entities to ensure consistent application of policing across the province by measuring compliance with prescribed standards.

#### Key functions of the IG include:

- Consulting with, advising, monitoring and conducting inspections of police service boards, Ontario Provincial Police (OPP) detachment boards, First Nation OPP boards, OPP Advisory Council, chiefs of police, special constable employers, police services and other policing providers regarding compliance with the Act and regulations.
- Receiving and investigating, if warranted, public complaints about members of
  police service boards, OPP detachment boards, First Nation OPP boards and the
  OPP Advisory Council regarding misconduct and policing complaints regarding
  the provision of adequate and effective policing, failure to comply with the Act
  and regulations, and policies and procedures.
- Reporting inspection findings, issuing directions to remedy or prevent noncompliance with the Act and imposing measures if the direction is not complied with, or, reprimanding, suspending or removing a board member if board member misconduct is identified.
- Conducting analysis regarding compliance with the Act and regulations.
- Reporting on the activities of the IG annually, including inspections conducted, complaints dealt with, directions issued and measures imposed; and compliance with the Act and regulations.

The Act also gives the IG and its inspectors the right to access closed police service board meetings.

Law Enforcement Complaints Agency

The Community Safety and Policing Act, 2019 will continue the office of the Independent Police Review Director as the Law Enforcement Complaints Agency (LECA), headed by the Complaints Director.

The LECA will receive and screen complaints from the public about the conduct of police officers. In addition, the LECA will have the authority to initiate an investigation in the absence of a public complaint if, in the Complaints Director's opinion, it is in the public interest to do so.

The Complaints Director may also undertake reviews of issues of a systemic nature that have been the subject of public complaints or investigations, or that may contribute or otherwise be related to misconduct.

The Special Investigations Unit

The Special Investigations Unit Act, 2019, (SIU Act), once in force, will set out a new legal framework for the SIU. The SIU Act will focus and clarify the mandate of the SIU to better ensure more timely, efficient, reasonable and transparent investigations. Key changes contained in the Act will focus the SIU's investigative resources where they are needed most – on criminal activity.

The Ministry of the Attorney General will continue to consult with law enforcement, community organizations and advocates to ensure their input is incorporated into the development of regulations under the SIU Act.

### Police Training

Training is developed and delivered in a manner that reinforces principles of fairness, equity and compliance with the Ontario *Human Rights Code* and *Canadian Charter of Rights and Freedoms*.

All Basic Constable Training (BCT) recruits undergo diversity-focused training designed to improve their ability to engage with the public and respond to victims of crime. This training focuses on improving recruits' understanding of the experiences of, and systemic barriers faced by, diverse communities, including racialized, Indigenous, First Nations and Metis, and Lesbian, Gay, Bisexual, Transgender, Queer and/or Questioning and Two-Spirited (LGBTQ2S) people.

Diversity and anti-racism training includes:

- Human rights framework for policing;
- Equity and inclusion;
- Harassment and discrimination;

- Defining police professional;
- Collection of Identifying Information in Certain Circumstances regulation;
- History of profiling in policing and the impact of racial profiling on the community;
- Profiling practices and the mindset behind it;
- Stereotyping;
- Bias free policing racial profiling vs. criminal profiling;
- Hate crimes and bias incidents of a non-criminal nature; and
- Practical skills scenario that reinforces academic learning on hate crimes.

#### Training on Indigenous issues includes:

- · Indigenous culture;
- Residential schools:
- · Land claims and treaties;
- First Nations Policing;
- Cultural appropriation;
- · Cultural practices; and
- Practical skills scenario that reinforces academic learning on Indigenous issues.

The Serving with Pride organization attends each intake to deliver a presentation to all recruits entitled "LGBTQ2S 101" which covers a number of issues related to the LGBTQ2S communities including historical events, current and appropriate terminology, gender expression, gender identity and other topics.

In addition to the standalone sessions, the above noted issues are interwoven and reinforced throughout the BCT program. For example, recruits are taught to respond to victims in a trauma-informed manner for all victims of crime acknowledging potentially vulnerable groups.

De-escalation and Mental Health Crisis Response Training

The Ontario Police College's current de-escalation training emphasizes communication techniques such as establishing rapport, threat management and conflict resolution and mediation.

The training specifically addresses scenarios in which police interact with people in crisis with a goal of resolving conflicts in a manner that protects the safety of the public, the person in crisis and police officers. Officers must also undertake follow-up training every 12 months. Police services are also encouraged to have policies and procedures in place as set out in the "Use of Force" Guideline. This includes procedures for impact weapons, aerosol weapons, conducted energy weapons, firearms and use of force reporting.

Training on the BCT program is reviewed and updated to reflect the most current information after every BCT intake.

Once in force, the *Community Safety and Policing Act, 2019*, will require all police officers, special constables and board members to successfully complete training related to human rights, systemic racism and the rights and cultures of Indigenous Peoples. This training will also be required for the new Inspector General of Policing, its inspectors, the Complaints Director at LECA and LECA investigators. This is part of the government's commitment to ensure that all interactions are conducted without bias or discrimination, and in a manner that promotes public confidence and keeps communities safe.

#### Mental Health and Addictions Initiatives and Investments

Dedicated Funding for Mental Health and Addictions Programs

Ontario's community mental health services include:

- assertive community treatment teams, case management, crisis intervention, early psychosis intervention, eating disorders programs, vocational programs, supportive housing and consumer/survivor initiatives, peer supports and other programs; and
- initiatives to keep people with serious mental health issues out of the criminal justice system which include, but are not limited to, court support and diversion, crisis intervention and safe beds.

In July 2018, Ontario announced its commitment to invest \$3.8 billion over 10 years, with the support of the Government of Canada, to develop and implement a comprehensive and connected mental health and addictions strategy. This includes \$174 million for mental health and addictions programs in 2019-20. As part of the \$174 million commitment of funds to support mental health and addictions in 2019-20, my ministry partnered with the Ministry of Health to announce \$18.3 million in new funding to support those affected by mental health and addictions challenges in the justice sector.

Specifically, in 2019-20, the Ministry of Health provided funding for an integrated set of mobile crisis services that assist in the de-escalation and stabilization of persons in crisis and their connection to community programming and supports to address their physical and mental well-being over the longer term, in order to prevent further crises. Five teams were implemented in 2019-20 with \$6.95 million of the \$174 million in new, annualized funding to develop and enhance mobile crisis services. Mobile crisis services partner police with community mental health organizations to respond to persons in mental health and addictions (MHA) crises and determine if the crisis:

- can be de-escalated and resolved at the scene;
- · warrants further psychiatric attention at hospital emergency rooms; or
- requires short-term community stabilization and reintegration.

Part of the \$18.3 million in new funding also includes \$2.5 million for various programs run by the ministry, one of which includes de-escalation training.

# Ministry of the Solicitor General Grant Programs

Apart from the dedicated funding for mental health and addictions programs highlighted above, the ministry also offers a number of grant programs that are primarily available to police services, working in collaboration with municipal and community partners, to support local Community Safety and Well-Being (CSWB) initiatives, including mental health-related programs. For example, under the 2019-20 to 2021-22 Community Safety and Policing Grant local and provincial priorities funding streams, the ministry is providing funding to 27 police services/boards for projects involving an integrated response between police and a mental health worker to respond to situations of crisis (e.g., Mobile Crisis Response Teams).

# Community Safety and Well-Being Planning

The ministry developed the *Community Safety and Well-Being Planning Framework: A Shared Commitment in Ontario* booklet, which includes the CSWB Planning Framework and a toolkit of practical guidance documents to assist municipalities, First Nations and their community partners as they engage in the CSWB planning process. The Framework encourages communities to work with various partners across sectors to proactively identify and address local priority risks in the community before they escalate and result in situations of crisis (e.g., crime, victimization or suicide). This involves reducing the number of incidents that require enforcement by shifting to more proactive, preventative programs and strategies that improve the social determinants of health (e.g., education, housing, mental health).

In support of this work, effective January 1, 2019, the government mandated municipalities lead the development of CSWB plans which identify and address local priority risks to safety and well-being, working in partnership with police services/boards and various other sectors, including health/mental health, education, community/social services and children/youth services.

Complementary to the Framework, a Situation Table is one type of multi-sectoral risk intervention model that is being implemented across our province.

The ministry also offers the Risk-driven Tracking Database (RTD), which allows for the collection of risk-based data and helps to inform the CSWB planning process, free of charge to communities across Ontario that are engaged in multi-sectoral risk intervention models, such as Situation Tables. As of June 2020, 60 sites have been onboarded to the RTD and any communities who are interested in being on-boarded to the RTD is encouraged to contact the ministry.

# Police-Hospital Transition Protocol

Additionally, to improve front-line response to persons experiencing a mental health or addictions-related crisis, my ministry partnered with the Ministry of Health to support the Provincial Human Services and Justice Coordinating Committee and CMHA of Ontario to develop a framework for local police emergency room transition protocols for persons apprehended under the *Mental Health Act*.

On June 3, 2019, the Ministry of the Solicitor General and the Ministry of Health jointly endorsed the release of *Improving Police-Hospital Transitions: A Framework for Ontario*, as well as the supporting toolkit, *Tools for Developing Police-Hospital Transition Protocols in Ontario*. The purpose of the framework and toolkit is to assist police services and hospitals with developing joint emergency department transition protocols, which are responsive to unique local needs, in order to ensure the seamless transfer of care for persons in a mental health or addictions crisis brought to a hospital by police officers.

I hope you find this information useful and I appreciate your municipality's support during this time of uncertainty.



Dear Mr. Glenn:

Over the past 2 years, our government has heard from farmers, municipalities and the broader agriculture community about the threat of on-farm trespass activities. We have heard that farmers are worried for their own safety, the safety of their families, their employees as well as the safety of their animals.

We listened to your concerns, and back in December 2019, I was honoured to introduce the <u>Security from Trespass and Protecting Food Safety Act, 2020</u> and to act on our government's commitment to protect farmers, agri-food businesses, farm animals and car food supply from the risks of trespass activities. The Act received Royal Assent on Jone 18, 2020.

I appreciate the strong support that I have received from our stakeholder partners, like you, on such an important piece of legislation. The COVID-19 outbreak has shown us more than ever, how important it is to have a steady, reliable food supply and to protect the health and safety of the agri-food workers who help feed us.

As you may be aware, we have recently seen a public safety situation grow more upont. Earlier this summer a demonstrator tragically died outside a meat processing plant. Since then, we have seen heightened tensions leading to greater risks for everyone involved. This has created a significant public safety concern that must be a lidressed to ensure everyone's safety.

As a result, I am announcing today a partial proclamation of the <u>Security from Trespass</u> and <u>Protecting Food Safety Act, 2020</u> that will come into effect on Wednesday September 2, 2020 at 12:01AM to address these immediate public safety concerns.

We are proclaiming sections 6(1), 7, 14(1)[3] and 15(1) of the Act, making it an offence to stop, hinder, obstruct or otherwise interfere with a motor vehicle transporting farm animals.

Regulation 950 under the <u>Provincial Offences Act (POA)</u> is also being amended so that tickets can be issued under Part I of the POA for a contravention of section 6(1) of the Act. This approach will allow for more immediate use of the relevant provisions to address the obstruction of motor vehicles transporting farm animals.

I am also pleased to inform you that a <u>Discussion Paper</u> has been posted on the regulatory registry, outlining the ministry's proposed approach for the regulatory items that are needed to make the rest of the Act come into force. It will be posted for public comment for 45 days, closing on October 15, 2020. Comments can also be sent directly by email to <u>SecurityFromTrespass.OMAFRA@ontario.ca</u>.

Londerstand the importance and urgency of this Act to many across the sector. However, before the remaining sections can be proclaimed into force, a number of the maintained via a regulation to operationalize the Act. These regulations are needed to ensure the act is clear, easily interpreted and fulfils its intended purposes. If the important that we take the time to hear from those impacted so we can take those comments into consideration in finalizing the regulation.

The remaining sections of the Act come into force upon proclamation by the Lieutenant Covernor in Council. Once fully proclaimed into force, the Act will recognize the unique rous associated with trespassing on farms and at processing facilities.



Hello to all once again.

The H&M COFI team has been hard at work! This past week, in partnership with ROCK Networks, White Fish River First Nation, the Municipality of Huron Shores has submitted an application to the Improving Connectivity for Ontario (ICON) Program. We are to be advised by September 25<sup>th</sup> if we have been successful in moving to Stage 2 of the program.

We were also able to appear before Minister of Infrastructure Laurie Scott and her team during the AMO conference and presented a power point slide show about H&M COFI. The presentation was followed up the next day with a chat with the Policy Director Zach Potashner, during which time I was able to touch up on the finer points of H&M COFI.

The Municipality of Huron Shores is looking at the incorporation of H&M COFI at this moment. The Stage 2 of ICON does require that we are incorporated. Therefore, we are reaching out to potential interested parties and inquiries are being investigated. It has been discussed that The Municipality of Huron Shores could apply for the incorporation and hold it in trust until such time when it would be transferred to a formed Board of H&M COFI. The Ad-Hoc Broadband Committee of Council is presently working on that issue in partnership with ROCK Networks. The report for the governance and financial plan should be available hopefully in mid-September, pending receipt of funding, and a meeting will be held for all supporters to determine the steps needed to form the H&M COFI Board.

As you can see "The Team" has been active on your behalf. We would like to thank all of the Municipalities, the First Nations and the Economic Development entities that have sent in their letters of support as well as the resolutions.

In regards to broadband statistics, we count the number of households in every municipality and or hamlets to determine numbers of supporters. The count now indicates that we have support representing more than 86% of the households in the two regions. That is fantastic.

For those who have not had the chance to support/participate in this project, you still have time. Please see the attachment to this memo for participation status to-date.

The Team is still pursuing funding for:

- (1) The governance model and the financial aspects;
- (2) The study for the high definition engineering study. Both our M.P. Carol Hughes and M.P.P. Michael Mantha are assisting in identifying sources of funding for those studies. These need to be done and ready by the end of November for Stage 2 of the ICON program, if we are successful in Stage 1.

We learned through the Sault Ste. Marie Innovation Centre that Bell Canada was also preparing to submit an ICON application. The concern is that, as with previous Bell options, not all homes will be served and of those that are, only ~2,000 will be offered speeds up to 1,500/940 Mbps and ~2,000 to 3,000 will receive the minimum recommended 50/10 Mbps. Our mission is to serve every household and business within the catchment area. We are holding strong for a community owned network, as the profits would benefit our Municipalities and First Nations. Recirculation of money within the area would truly provide us the economic boost so desperately needed.

The Team is requesting that if you have a meeting with a Minister of the Province, or any person in a position to help us, please make it a point to bring up H&M COFI and highlight the needs for broadband for the region. H&M COFI is the answer to many things for our communities. Together we can make a difference.

I am pleased to report on the progress of The Huron Shore & Manitoulin Island Community Owned Fibre Infrastructure (H&M COFI) Broadband project. In August, we submitted a Stage 1 grant request to the Improving Connectivity for Ontario (ICON) Program, and on 25 September 2020, our project was selected for the next stage. The Stage 2 submission is a more detailed report of the H&M COFI project, which will seek up to 25% or \$37.5M of the project's expected cost and is due 28 November 2020. If selected in Stage 2, the funds would allow us to commence in April 2021.

Last week, our H&M COFI partners, ROCK Networks Inc., and I presented to FedNor a request for funds required to complete the Stage 2 submission. It was well-received, and due to the ICON Program's late November deadline, we anticipate a response shortly. The documents will provide a Governance and Business Operating Structure and High-Level Engineering Design for H&M COFI. In addition to the ICON submission, the documents enable requests to federal programs that fund rural broadband projects. As federal funding can support up to 50% of the cost of H&M COFI, these documents are essential for our progress forward.

We have now entered a point of the project that will require a timely response from First Nations and Municipalities to address questions of an administrative nature that might be necessary for provincial and federal grant submissions. Therefore, we ask that you please provide the names, email addresses and phone numbers of the primary and alternate points of contact who are able to quickly respond to administrative queries. I look forward to working closely with you as we progress with the H&M COFI project and deliver a genuinely world-class network for the peoples of Huron Shore and Manitoulin Island.
