# 6. STAFF AND COMMITTEE REPORTS

## a. Road Superintendent Verbal Update

Road Super Mike Pigeon advised Council that everything is going well. He discussed the cost of 1000t of winter sand based on 2021 prices to buy direct and store it as opposed to purchasing it from an outside source at almost three times the cost. By ordering 1000t we will have sand in the bank for the next season. Several places are running short so we will be well served to stock up.

Blades: Council agreed to purchase the blades for the truck at the December meeting. For the grader the cost today would be \$3000 for demo blades. Regular cost is \$3800. The cost for both sets today is \$6500 plus shipping which will only be paid once. Six sets of steel blades are \$2000 for the grader. Historically we would go through 8 sets in a year. Saving \$5500 over five years at the current price. Several other municipalities are using them with great success as they use less sand since the roads are cleaner, and vibration is reduced so all around better product.

# b. Proposed Severance and Development adjacent Aggregate

J. Brice presented information regarding a potential severance on MacLennan Road, noting the Official Plan provision about development in the Mineral Extraction designation. The proposed owner wants to build a residence in the mineral extraction zone which would not typically be permitted, however a precedent has been set by permitting prior residential development close by, and the vacant parcel being severed has the potential for further residential development. Council discussed and agreed to support the application for consent.

That Council support the application for consent, provided that the Township receive up to 5% of the value of the severed portion for parkland dedication; and



That any portion of the traveled road known as MacLennan Road that is located on the subject property be transferred to the Township at the expense of the applicant. Carried

Fire Training Modernization: Councillor Farrar advised that, following the closure of the Ontario Fire College in 2021, the Solicitor General and Office of the Fire Marshal have advised of Mandatory Certification requirements which will cause significant changes to training requirements for fire departments. The new requirements will not only be enormously expensive but will also significantly impact the ability to attract, train and retain firefighters. D. Farrar and L. Smith will participate in a zoom meeting with the OFM during the consultation period. Small and rural municipalities with volunteer departments will not be able to meet the new requirements and it will be important to get that message to the OFM and the Province.
