c. GFL Landfill Contract Revisions

A meeting was held with GFL on July 6 to discuss rates and monthly expenses. The amount of garbage produced was vastly underestimated when the initial negotiations occurred, and has resulted in more frequent collections and higher costs than expected. The Landfill Committee had requested a quote on a 53 yd bin to place inside the bunker.



GFL agreed to reduce some of the lift rates but asked the Townships to continue with the current system for another month as the system in place now is established across the Province. Consistency creates efficiency but erring from this system with different sized bins, schedules and collection systems could be more costly.

- Four of five council members have filed nomination paper. Council will not be in a restricted acts situation (lame duck), so business as usual until election day.
- Tax bills and newsletter going out next week focusing largely on landfill news.

Existing and Proposed Agricultural Designation

BACKGROUND / OVERVIEW

Three maps are attached showing (A) existing Agricultural Designation for Tarbutt in the Official Plan, (B) the Proposed Ag designation, and (C) a comparison of the two.

Council is aware that an Official Plan review is currently underway and expected to be ready for presentation to the public prior to the end of this year. With certain limitations, each municipality within the Planning area (Desbarats to Echo Bay) can determine the lands they feel should or should not be designated into each class, i.e. rural, agricultural, shoreline environmental protection, etc. These designations are based, in part, on the classification of soil assigned by the Province.

In several locations, lands that are currently designated as Agricultural are not suitable for farming. It has been suggested that these lands be moved from Agricultural to Rural, which would allow for more agricultural related, residential development and home based business.


FINANCIAL IMPACT

There is no immediate financial impact of this information, however the long term benefit would be an increase in residential development on lands to be designated as Rural.




Existing Agricultural Designation for Tarbutt Township Official Plan






Proposed Agricultural Designation for Tarbutt Township for Joint Official Plan

Re: Christmas Closure

BACKGROUND / OVERVIEW

Administrative staff respectfully request Council's approval to close the municipal office the week of December 26th to allow for Christmas celebrations and regeneration. Christmas Eve and Christmas Day both fall on the weekend, making Monday the 26th and Tuesday the 27th statutory holidays. The remaining three days that week, December 28, 29 and 30, would be taken as vacation time or to use banked time prior to the end of the year.

As New Years Day falls on a Sunday, Monday, January 2 is a statutory holiday. The municipal office would return to regular hours on Tuesday, January 3, 2023.

The Landfill would normally be open Saturday, December 24 and 31 until 5 pm. Rather than having the site open all day, staff have agreed to the possibility of a half day, 8 am to 12 noon, or 9 am to 1:00.

The roads department will technically be closed during that time period as well but will work as needed for winter operations.

If this recommendation is approved, the municipal office would be closed from 4:00 pm on Friday, December 23 until Wednesday, January 3.

FINANCIAL IMPACT

There is very minimal financial impact save for reduced use of heat and hydro. Staff would be required to use their own time for December 28, 29 and 30.

RECOMMENDATION:

Be it resolved that the report from the Clerk regarding Christmas Closures be received; and That Council authorizes the closure of the municipal office from the close of business on Friday, December 23 until 9 am on Tuesday, January 3, 2023.
