1. CALL TO ORDER – CLERK

The Clerk called the Inaugural Council Meeting of the 2022 – 2026 term to order at 6:00 pm, welcoming returning council members and newly elected member Jacqui Nagel.

7. STAFF AND COMMITTEE REPORTS

a. Council Orientation

Each member of Council was provided with a Council Orientation binder containing information pertinent to their role as a council member, and to local government in general. Topics covered included the Strategic Plan; Procedural By-law and Notice Provisions; Privacy and Confidentiality; Municipal Conflict of Interest; Code of Conduct and Council Staff Relations Policies; appointments to Boards and Committees; Accessibility and Health and Safety policies; copies of the 2022 Budget and a year to date financial statement; township maps; and a series of commonly used by-laws and policies.

Council members were asked to keep the binder handy for easy reference, and so that new policies, by-laws, legislative and budget updates can be added as they are approved for use.



b. Committee Appointments

Council members were encouraged to indicate which committees they wished to participate in.

The Clerk suggested that it may be beneficial to have one community member from each community to sit on the Joint Landfill Committee, to provide greater representation.

Statutory Positions to be Appointed

The Clerk suggested that the following positions be advertised in the event that someone in the community has a special interest or a background in an area that would be beneficial.

Fence Viewer – three members of the community with interest and/or expertise in relevant areas. Council members are not eligible to be fence viewers.



Livestock Valuer – one member of staff or community

Weed Inspector – one person to be appointed. J. Nagel volunteered. OMAFRA provides virtual training, which will be offered in the spring.

Health and Safety Representative - Jared Brice represents employees

Other Representation

Algoma District Municipal Association (ADMA) – Mayor Smith Algoma District Services Administration Board – to be elected upon nomination

10. OTHER BUSINESS

Council agreed to provide an acknowledgement for outgoing council member Ruth Wigmore, who was the longest serving council member, having been first elected and serving consistently since 2000.

The matter of exterior illumination has come up again after a visiting consultant expressed concern over the lack of light in the parking lot. The light installed on the fire hall does not extend to the office doors, and there is little to no lighting in the parking lot. Staff have requested the installation of a yard light that would shine onto the parking lot. Councillor Farrar suggested LED flood lights be installed on the building that would extend across the parking lot. Council agreed that a permanent solution needs to be put in place as soon as possible, and the Health and Safety Representative advised.

The Clerk advised that the area municipalities have been discussing the possibility of hiring a "regional" by-law enforcement officer to cover several communities, as there is not sufficient work for any one municipality to keep a trained person occupied. This was well accepted by Council, who confirmed their desire to participate in the process, spearheaded by The Township of Plummer.
