#### **REPORT TO COUNCIL**

Re: Delegation of Authority

#### BACKGROUND / OVERVIEW

Council is aware that the Treasurer position, which is currently unoccupied, also includes the role of Deputy Clerk. The purpose of the duplicate roles is to ensure that there are staff members available who have the authority, both legislative and locally, to perform the statutory duties of either the Clerk, or the Treasurer. While the Treasurer/Deputy Clerk is away from the office, there is no one with the authority to perform the statutory duties which are incumbent on the municipality.

The intent of the delegation is not to add to or increase the workload of the Administrative/Planning Assistant, but to ensure that certain statutory duties can continue to be carried out in the absence of the Clerk. J. Brice has both the knowledge and understanding of this role, and the responsibility incumbent on it. He has agreed to the appointment.

#### FINANCIAL IMPACT

There would be no financial impact if the clerk were unavailable for one or two days; however if the Clerk is unable to work for more than three consecutive days, the salary of the Admin/Planning Assistant should be adjusted to reflect the additional, longer term responsibilities that would be required. The actual step adjustment in such a case will be discussed in closed session.

#### SUMMARY

In the prolonged absence of the Clerk, the Admin/Planning Assistant should have the authority to commission documents, discuss Municipal Freedom of Information matters with residents, and conduct other daily duties required by statute.

#### **RECOMMENDATION:**

Be it resolved that the report from the CAO/Clerk regarding the Delegated Authority of the Clerk be received; and

That Council authorizes the designated authority of the Clerk to Jared Brice, Administrative/ Planning Assistant, to assume statutory duties in the absence of the Clerk; and

That the absence of the Clerk for a period of more than three consecutive days shall result in a step up to the wage of the Admin/Planning Assistant.

# THE CORPORATION OF THE TOWNSHIP OF TARBUTT

### BY-LAW 2023 -

A By-law to appoint a Municipal By-law Enforcement Officer under the *Municipal Act* and related legislation, and to repeal By-law 19-2007.

WHEREAS Section 227 of the *Municipal Act*, S.O. 2001, c.25, as amended, provides for officers and employees of the Township to carry out other duties required under this or any Act and other duties assigned by the Township; and

WHEREAS Section 425 (1) of the *Municipal Act*, as amended, provides that a Township may pass by-laws providing that a person who contravenes a by-law of the Township is guilty of an offence; and

WHEREAS Section 436 (1) of the *Municipal Act*, as amended, provides that a Township has the power to pass by-laws providing that the Township may enter on land at any reasonable time for the purpose of carrying out an inspection to determine whether or not the property owner is in compliance with a by-law passed under this Act, a direction or order of the Township under this Act, or an order made under Section 431 of the *Municipal Act*; and

WHEREAS Section 447.4 (1) of the *Municipal Act*, as amended, provides that without limiting sections 9, 10 and 11, those sections authorize a Township to enter into agreements with a person or body in relation to matters of mutual interest for the purpose of coordinating the enforcement of by-laws, statutes and regulations; and

WHEREAS section 15 of the *Police Services Act*, R.S.O. 1990, c.P.15, as amended, authorizes the appointment of Municipal Law Enforcement Officers who shall be peace officers for the purpose of enforcing the by-laws of the Township; and

WHEREAS the Council of The Township of Tarbutt deems it desirable to appoint a Municipal By-law Enforcement Officer in connect with the enforcement of its municipal by-laws;

NOW THEREFORE BE IT RESOLVED THAT the Council of the Corporation of The Township of Tarbutt hereby enact the following:

- 1. That Brant Coulter be hereby appointed as the Municipal By-law Enforcement Officer for The Township of Tarbutt with the power and authority granted under the *Municipal Act*, its regulations, and other relevant legislation.
- 2. That terms of this appointment shall be provided in the agreement titled Schedule "A" and attached hereto.
- 3. That the Municipal By-law Enforcement Officer has the authority to enforce any By-laws passed prior to enactment of this By-law, and any By-laws duly enacted in the future.

The Township of Tarbutt Municipal By-law Enforcement Officer Appointment By-law 2023 –

- 4. Unless the contrary intention appears in this by-law, words importing the masculine gender only shall include females as well as males and the converse.
- 5. That By-law 19-2007 and any previous by-law, clause or resolution which conflicts with the purpose and intent of this by-law shall be hereby repealed.
- 6. That the terms of this Agreement may from time to time be amended by Resolution.

READ A FIRST AND TAKEN AS READ A SECOND AND THIRD TIME AND FINALLY PASSED in open session this Eighteenth day of October, 2023.

# THE CORPORATION OF THE TOWNSHIP OF TARBUTT BY-LAW 2023 -

A BY-LAW authorizing the Mayor and the Clerk to enter into a Data Sharing and Services Agreement with the Municipal Property Assessment Corporation (MPAC), for access to and use of data and data products.

WHEREAS pursuant to section 2 (5) subsection (3) of the Municipal Act, S.O. 2001, c 25, as amended, the power of the Council of the Corporation of The Township of Tarbutt shall be exercised by By-Law; and

WHEREAS Section 8 (1) of the Municipal Act, 2001, as amended, provides that the powers of a municipality under this or any other Act shall be interpreted broadly so as to confer broad authority on the municipality to enable the municipality to govern its affairs as it considers appropriate, and to enhance the municipality's ability to respond to municipal issues; and

WHEREAS Section 9 of the Municipal Act, 2001, as amended, grants municipalities the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under the Act; and

WHEREAS The Township of Tarbutt desires access to data collected and provided by MPAC regarding properties within its jurisdictional boundaries and agrees to provide MPAC with access to the municipal documents and information noted in Section 3 of the Agreement; and

WHEREAS the Agreement also covers MPAC permitted uses of municipal documents, municipal permitted uses of MPAC data products, and the terms and conditions of the use of MPAC data;

NOW THEREFORE BE IT RESOLVED THAT the Council of The Corporation of The Township of Tarbutt enacts as follows:

- 1. THAT the Mayor and the Clerk of the Corporation of The Township of Tarbutt are hereby authorized to execute the Data Sharing and Services Agreement between The Township of Tarbutt and the Municipal Property Assessment Corporation (MPAC) commencing January 1, 2024.
- 2. THAT this Agreement is attached as Schedule "A" to this By-law.
- 3. At any time in this By-law or the attached Agreement, "May" shall be construed as permissive, and "Shall" shall be construed as imperative.
- 4. THAT any previous policy, by-law or resolution, or any section, clause which conflicts with this by-law be and is hereby repealed.
- 5. THAT the Mayor and the Clerk shall have the authority and direction to execute the above

noted Agreement, including any renewal agreements or administrative amendments.

6. THAT this Agreement shall come into force and take effect upon the effective date noted in the attached Schedule.

READ A FIRST, AND TAKEN AS READ A SECOND AND THIRD TIME and finally passed this Eighteenth day of October, 2023.

#### MUNICIPAL PROPERTY ASSESSMENT CORPORATION SOCIÉTÉ D'ÉVALUATION FONCIÈRE DES MUNICIPALITÉS

#### Data Sharing and Services Agreement

This Data Sharing and Services Agreement (the "DSSA") integrates and clarifies many existing MPAC-Municipality agreements including: The Service Level Agreement (the "SLA"), the Municipal License Agreement and Product Use Sheets, the Municipal Connect License and the Ontario Parcel Master Agreement General Municipal Licence Agreement (the "OPMA GMLA").

The DSSA contains the following areas of focus:

- The Service Level Agreement establishes service levels for a comprehensive set of MPAC services and dependencies that the Municipality will make reasonable efforts to fulfill. These are the same service levels established by MPAC in 2018 with all municipalities. Dependencies include the Municipality's timely delivery of building permits and building plans to MPAC. Notification of missed service levels has been reduced to 10 days and escalation procedures have been clarified.
- The *MPAC Permitted Uses of Municipality Documents* clarify how MPAC will use information supplied by the Municipality to fulfill its legislated mandate. In addition to meeting service levels, performing property assessment activities and fulfilling other statutory duties, MPAC will also use the Municipality's information to update its databases to provide assessment data to the Municipality, other municipalities, taxpayers and stakeholders, and commercialize data and insights to offset the Municipality's levy payments. The Municipality's information will be protected from disclosure to, and unauthorized access by, third parties.
- The *Municipality Permitted Uses of MPAC Data Products* provide the Municipality and its consultants with expanded uses of MPAC data for internal planning, internal operational and external distribution uses. It also provides easier access to license custom products and for Municipality-owned and funded entities to access MPAC data.
- Finally, the **Data Terms and Conditions of Use** provide a reciprocal set of terms and conditions that govern all information licensed under this DSSA. The terms and conditions acknowledge the intellectual property rights of licensed information and require that both MPAC and the Municipality protect information (including third party information) in accordance with their respective obligations under the *Municipal Freedom of Information and Protection of Privacy Act* (MFIPPA), the *Assessment Act* and this DSSA. Remedies are provided in the event of unauthorized use or disclosure of the information.

The DSSA was developed in consultation with representatives from the Municipal Liaison Group and is intended to be a framework for the continued evolution of the relationship between MPAC and the Municipality. The DSSA includes commitments for MPAC to regularly update service levels, dependencies and data products in consultation with the Municipal Liaison Group.

Please find attached the OPP municipal policing 2024 Annual Billing Statement package.

This year's billing package includes a statement for the 2022 year-end reconciliation. The final cost adjustment calculated as a result of the 2022 annual reconciliation has been included as an adjustment to the amount being billed to the municipality during the 2024 calendar year.

The most current OPPA uniform and civilian collective agreements expired on December 31, 2022. The estimated salary rates incorporated in the 2024 municipal policing annual statements are based on the 2022 rates, set in the last collective agreements, with a 2.01% overall general salary rate increase applied, representing a 1% general salary rate increase for each of calendar years 2023 and 2024. The reconciliation of both 2023 and 2024 costs will include a reconciliation of salary costs based on rates set in applicable collective agreement settlements.

The final reconciliation of the 2024 annual costs will be included in the 2026 Annual Billing Statement.

#### Re: Declaring Intimate Partner Violence (IPV) an Epidemic

At its Council Meeting of September 12, 2023, the Council of the Corporation of the City of Cambridge passed the following Motion:

WHEREAS the safety of our community and its members is of extreme importance to every single Cambridge resident, as well as to Cambridge Council;

WHEREAS intimate partner violence, often referred to as domestic violence, means any use of physical or sexual force, actual or threatened in an intimate relationship, including emotional and/or psychological abuse or harassing behaviour, and persons of any gender or sex can be victims of intimate partner violence;

WHEREAS Waterloo Region is experiencing a rise in intimate partner violence (IPV) and domestic violence during and after the COVID-19 pandemic, and the Waterloo Region Police Service (WRPS) experiences an average of 17 calls related to IPV per day, with a total of 6,158 calls in 2022 and 66,000 calls for service in total, despite the fact that 70% of IPV incidents go unreported due to feelings of shame, fear, and secrecy;

WHEREAS the WRPS has laid more than 35,000 charges related to IPV, or an average of 3,500 per year;

WHEREAS in 2022, five out of six homicides in Waterloo Region stemmed from IPV and domestic violence, with over 3,800 criminal charges issued by WRPS in relation to IPV;

WHEREAS between 2012 and 2022, the WRPS received a total of 20,870 calls related to IPV in Cambridge, and laid a total of 11,020 charges related to IPV in Cambridge;

WHEREAS Indigenous women are approximately 3.5 times more likely to experience some form of intimate partner violence than non-Indigenous women, and the homicide rate for Indigenous women and girls is approximately 6 times higher than for non-Indigenous women and girls, and Indigenous women are 12 times more likely to be murdered or missing than any other women in Canada, and 16 times more likely than white women;



WHEREAS violence against women costs the national justice system, health care systems, social services agencies and municipalities billions of dollars per year, and municipalities are on the front line in addressing gender-based violence;

BE IT RESOLVED THAT the City of Cambridge joins over 30 other Ontario municipalities in supporting the Recommendation #1 from the Culleton, Kuzyk and Warmerdam Inquest (C.K.W. Inquest) in formally declaring intimate partner violence (IPV) as an epidemic;

AND THAT the Province of Ontario be requested to declare that intimate partner violence and violence against women is an epidemic, in accordance with Recommendation #1 of the C.K.W. Inquest;

AND THAT Cambridge recommends that Waterloo Regional Council integrates intimate partner violence in the Region's Community Safety and Wellbeing Plan, in accordance with Recommendation #10 of the C.K.W. Inquest, and set out gender-based violence/intimate partner violence as a separate priority within the plan;

AND FURTHER THAT the City Clerk be directed to send a copy of this motion to the Region of Waterloo, Province of Ontario, The Right Honourable Prime Minister, Members of Parliament, Provincial Members of Parliament, United Nations, and all Ontario Municipalities.

I am writing to you today to share an update on Bill 21, Fixing Long-Term Care Amendment Act (Till Death Do Us Part), 2022, and to request your support for this important legislation.

Bill 21 amends the Residents' Bill of Rights set out in section 3 of Fixing Long-Term Care Act, 2021 by adding the right of residents not to be separated from their spouse upon admission but to have accommodation made available for both spouses so they may continue to live together.

The Act was inspired by Cambridge resident Jim McLeod, who will have been separated from his wife of 65 years Joan, on September 17, 2023. Nearly 6 years later, Jim continues to champion spousal reunification. He often says that he will talk to anyone and has two giant binders full of his advocacy work on the Bill. Last week, he told me that his heart is breaking because of his separation from Joan. He has brought other seniors who are separated from their spouses into the advocacy – you cannot sit with these folks for any amount of time and not care deeply about this legislation.

I know that you value the many contributions that older adults have made to Waterloo Region, and care deeply that they can live their final years with dignity and love. I am hoping you will consider bringing a motion forward to your Council, in support of the Till Death Do Us Part Act. Your support will help us to keep attention on this important legislation, so that it can finally be called to the Standing Committee on Social Policy – one step closer to Royal Assent.

I would be happy to discuss the Bill with you further, via phone call or an in-person meeting at your convenience. Thanks in advance for considering my request.

#### BACKGROUND:

On November 15, 2022, the Till Death Do Us Part Act, passed second reading in the Ontario legislature after being introduced for the third time in September 2022. The bill was then referred to the Ontario Legislature's Social Policy Committee. I have been pushing for the Standing Committee on Social Policy to schedule a time to begin the work of reviewing Bill 21 since November 2022. Today marks 286 days since the Act passed second reading at the Legislative Assembly of Ontario. Unfortunately, the Bill has yet to be called to committee.

Bill 21, which was formerly Bill 153 and 95, respectively, had passed second reading and was sent to the Justice Committee in December 2019, but was wiped off the order paper when Premier Ford prorogued the house in 2021. It was reintroduced early 2022 but did not have time to progress before the election.

Since I first introduced this Bill in 2019, the number of people who've reached out to my offices with heartbreaking stories of couples entering long-term care who are torn apart has skyrocketed. Simply put, Ontario seniors deserve dignity in care and should have the right to live with their partner as they age. Of note, Nova Scotia passed similar legislation, titled the Life Partners in Long-Term Care Act in 2021.

Following many meetings with stakeholders, it's clear that "care campuses" which offer different levels of care (independent, assisted living and long-term care) are the progressive model for investing in quality care for Ontario's aging population. Care campuses are an essential element to keeping couples together as they often age at different rates. This level of choice has been brought to my attention as especially important to rural and northern municipal leaders across Ontario. The care campus model for seniors housing that builds different levels of care has unique financial savings that will be critical as we grapple with a rapidly aging province.

We need the Bill to be called to the Standing Committee on Social Policy as soon as possible. We know that couples who are separated across Ontario cannot wait any longer for this legislative change to be made.

Re: Childcare availability in Ontario

Dear Minister Thompson:

The Municipality of Bluewater is concerned about the critical issue of childcare availability in our province and how it is linked to educational requirements and low wages within the childcare sector. We believe that addressing these issues is crucial for the well-being of our families and the future prosperity of Bluewater and Ontario.

Childcare availability in Ontario has become an increasingly pressing problem for parents and guardians. Access to affordable, high-quality childcare is essential for families to balance work and family responsibilities, and it plays a vital role in supporting the early development and education of our children. However, the lack of available childcare spaces is a significant barrier for many parents, limiting their ability to participate fully in the workforce and achieve financial stability.

We suspect that one of the key factors contributing to the shortage of childcare spaces is the educational requirements imposed on childcare workers. Additionally, low wages within the childcare sector are a significant concern. Many qualified and passionate individuals are discouraged from pursuing a career in childcare

due to the low wages and limited opportunities for professional growth. This low-wage structure not only makes it difficult to attract and retain skilled childcare educators but also effects the quality of care children receive. Investing in the professional development and fair compensation of early childcare educators is essential to ensure that our children receive the best care possible and the best start in life.

# To address these issues and improve childcare availability in Ontario, the Municipality urges you to consider the following actions:

1. Review and Reform Educational Requirements: Work with relevant stakeholders to review and potentially revise the training methods of early childcare educators, striking a balance between safety and accessibility by increasing the praxis model to learning.

2. Invest in Professional Development: Advocate for increased investment in professional development opportunities for childcare workers to enhance their skills and qualifications.

3. Increase Wages: Support initiatives to increase the wages of childcare workers, ensuring that they are paid a fair and competitive salary for the vital work they do.

4. Expand Funding: Work to secure additional funding for the expansion of childcare services and facilities, especially in underserved and rural communities.

5. Promote Public Awareness: Raise public awareness about the importance of accessible and high-quality childcare services and the need for policy changes.

This is an urgent matter that is expected to worsen and your timely response to these concerns is needed.

By addressing these issues, we can make significant strides toward improving childcare availability in Bluewater and Ontario and ensuring that families have the support they need to thrive. We kindly request your timely support and advocacy on these matters and would be grateful for any updates or initiatives related to childcare reform in our province.

Thank you for your attention to this critical issue. We look forward to your continued dedication to the well-being of Ontario's families and children.

**THAT** Council receive the correspondence from the Township of Puslinch regarding Illegal Land Use Enforcement for information purposes; and

**FURTHER THAT** Council endorse and support the resolution from the Township of Puslinch and Council direct staff to send a duplicate resolution to associated ministries and Ontario Municipalities.

The resolution reads as follows:

That the Illegal Land Use Enforcement Taskforce's mandate be expanded to include other types of illegal land uses and not solely on illegal trucking land uses; and

That the Province be requested to strengthen municipal enforcement powers by:

- Amending the Municipal Act to enable municipalities to physically bar entry to properties where illegal land uses that have significant detrimental impacts on adjacent residential properties, the environment or create unsafe situations;
- Increasing the maximum penalty amounts in the Planning Act to \$50,000 for an individual upon conviction and on a subsequent conviction, not more than \$25,000 for each day in which the contravention has continued after the day in which the person was initially convicted; and

 Including provisions to ensure a corporation is liable to fines of not more \$100,000 upon first conviction and not more than \$50,000 for each day in which the contravention has continued after the day in which the corporation was initially convicted.
