BACKGROUND / OVERVIEW

Each year the municipalities of East Algoma collaborate to produce a tender in order to acquire the materials, tools and equipment necessary to conduct their roads projects for the year.

The Road Supers have, this year, decided to expand the number and list of items to be included in the tender to include equipment parts, tools and other sundry items which can be purchased at a reduced cost when using a group rate.

The following items are proposed to be included in the 2024 tender:

Road Surfacing

A new process called "fogging" is being highly recommended after good success in extending the life of the road and the materials placed on it, and also reducing the amount of gravel that shifts off the shoulders. The fogging is an additional cost but is expected to extend the life of the road resurfacing by an additional five years. All municipalities participating in the Amalgamated Tender would have to agree to accept the bids from contractors who provide this service.

Dear Carol,

This letter is in response to communications you and Daniel Cedolia have had back and forth about our proposed environmental scope of work at our business location, Loonie Toons Pontoons, 7950 Hwy 17 E. in Desbarats.

We are currently gathering information and scope of work/costs to potentially undergo some soil remediation work on our property. When we purchased the property from Curtis Mills (Desbarats Service Station), we were provided with an extensive collection of paperwork and information from when Petro Can completed a very supposedly comprehensive remediation of the site back in the 1990s. We have since removed the gas tanks from the ground that were placed there following this clean up and the soil and tanks looked like they were pristine.

It appears that this current soil contamination is very old, and we suspect it was there when Petro Can did their clean up; however, standards were different then. We now find ourselves in a "catch 22" situation where we are cleaning up someone else's mess.

Like any small business, we cannot afford an unforeseen project such as this one, especially since it was not even our mess that we are potentially going to clean up. What we are requesting from council is that we are offered some leniency in the dumping fees. We have received estimates for approximately 170 -185 dump truck loads.

We have heard that you have provided leniency and even waived fees for a similar clean up at the 17 E Trading Post. It might we worth taking into consideration that when we took over the property in 2017, we turned a dilapidated eyesore of a property into a thriving, bustling sustainable business within the hamlet of Desbarats.

We consider ourselves to be conscientious and community-minded business owners, and we would hope that you can extend some grace towards us should we undertake this endeavour.

THE CORPORATION OF THE TOWNSHIP OF TARBUTT BY-LAW 2024 - 01

A BY-LAW TO PROVIDE FOR AN INTERIM TAX LEVY AND TO PROVIDE FOR THE PAYMENT OF TAXES AND FOR PENALTY FOR UNPAID TAXES FOR THE YEAR 2024.

WHEREAS Section 317 (1) of the *Municipal Act*, S.O. 2001, c.25, as amended, provides that the Council of a local municipality may, in 2024 before the adoption of the estimate for the year, pass a by-law to levy on the whole of the assessment for real property according to the last revised assessment roll, a sum not to exceed 50 percent of the total amount raised for all purposes for the previous year by the levying of tax rates on all the properties that, in the current year, are in the property class; and

WHEREAS the Council of the Corporation of The Township of Tarbutt deems it expedient to make the levy authorised by the said Section 317 (1) in the year 2024;

NOW THEREFORE the Council of the Corporation of The Township of Tarbutt enacts as follows:

- 1. The interim taxation on all the properties in the current year property class will be due in two equal instalments under this By-law, instalment dates being Wednesday, February 28, 2024 and Friday, April 26, 2024.
- 2. A percentage charge of one and one quarter (1¼ %) per cent shall be imposed as a penalty for non-payment of taxes and shall be added to the tax instalment or part thereof remaining unpaid on the first day following the said due date, and one and one quarter (1¼ %) per cent shall be imposed and shall be added to the tax instalment or part thereof remaining unpaid on the first day of each month in which default continues. On all other taxes in default on January 1, 2024, interest shall be added at the rate of one and one quarter (1¼ %) percent per month or fraction thereof, and all by-laws and parts of by-laws inconsistent with this policy are hereby rescinded.
- 3. The Tax Collector shall, not later than 21 days prior to the date the first instalment is due, mail or cause to be mailed to the address of the residence or place of business of each person indicated on the last revised assessment roll, a notice setting out the payment required to be made pursuant to this by-law, the date by which it is to be paid to avoid penalty, and the particulars of the penalties imposed by this by-law for late payment.
- 4. Taxes shall be payable to the Corporation of The Township of Tarbutt.
- 5. The Collector and/or Treasurer are hereby authorised to accept part payment from time to time on account of any taxes due, and to give a receipt if requested to do so for such part payment, provided that acceptance of any such part payment shall not affect the collection of any percentage charge imposed and collectible in respect to non-payment of taxes or of any instalment thereof. The rates of taxation will be levied when the assessment on real and commercial property is set and the levies are received from the Provincial Government.
- 6. Any previous by-law or resolution which conflicts with this by-law is hereby repealed.

READ A FIRST AND TAKEN AS READ A SECOND AND THIRD TIME and finally passed in open council this Seventeenth day of January, 2024.

THE CORPORATION OF THE TOWNSHIP OF TARBUTT BY-LAW NO. 2024 - 02

A BY-LAW AUTHORIZING THE BORROWING OF MONEY TO MEET CURRENT EXPENDITURES OF THE TOWNSHIP OF TARBUTT, AND TO REPEAL AND REPLACE BY-LAW 2023 - 02.

WHEREAS the provisions of subsection 407 (1) of the *Municipal Act*, S.O. 2001, c.25, as amended, permits a municipality to authorize temporary borrowing until the taxes are collected and other revenues are received, of the amount Council considers necessary to meet the current expenditures of the municipality for the current year; and

WHEREAS the total amount borrowed at any one time, plus any outstanding amounts of principal borrowed and accrued interest, except with the approval of the Ontario Land Tribunal, is limited;

NOW THEREFORE THE COUNCIL OF THE TOWNSHIP OF TARBUTT ENACTS AS FOLLOWS:

- 1. The Head of Council and the Treasurer are authorized on behalf of the Municipality to borrow from time to time by way of promissory note or bankers' acceptance from CANADIAN IMPERIAL BANK OF COMMERCE ('CIBC') a sum or sums not exceeding in the aggregate \$430,000.00 to meet, until taxes are collected, the current expenditures of the Municipality for the year (including the amounts required for the purposes mentioned in subsection 407 (1) of the Act) and to give to CIBC promissory notes or bankers' acceptances, as the case may be, sealed with the Corporate Seal of the Municipality and signed by the Head and Treasurer for the sums borrowed plus interest at a rate to be agreed upon from time to time with CIBC.
- 2. All sums borrowed pursuant to this by-law, as well as all other sums borrowed pursuant to the Act in this year and in previous years from CIBC for any purpose will, with interest thereon, be a charge upon the whole of the revenues of the Municipality for the current year and for all preceding years as and when this revenue is received.
- 3. The Treasurer is authorized and directed to apply in payment of all sums borrowed plus interest, all of the moneys collected or received on account in respect to taxes levied for the current year and preceding years or from any other source which may lawfully be applied for this purpose.
- 4. The Treasurer is authorized to furnish to CIBC a statement showing the nature and amount of the estimated revenues of the Municipality not yet collected and also showing the total of any amounts borrowed that have not been repaid.
- 5. Any previous by-law or resolution which conflicts with this By-law is hereby repealed.

READ A FIRST, AND TAKEN AS READ A SECOND AND THIRD TIME AND FINALLY PASSED in open council this Seventeenth day of January, 2024.

THE CORPORATION OF THE TOWNSHIP OF TARBUTT

BY-LAW 2024 - 03

A BY-LAW TO ESTABLISH TAX RATIOS FOR MUNICIPAL PURPOSES FOR THE YEAR 2024.

WHEREAS Section 308 (2) of the *Municipal Act*, 2001, S.O., c. 25, as amended, requires the municipality to establish tax ratios; and

WHEREAS Section 308 (4) of the *Municipal Act*, as amended, provides that a single tier municipality shall pass a by-law in each year to establish the tax ratios for that year; and

WHEREAS the tax ratios determine the relative amount of taxation to be borne by each property class;

NOW THEREFORE the Council of the Corporation of The Township of Tarbutt hereby enacts as follows:

- 1. THAT for the taxation year 2024 the tax ratio for property in the following classes will be:
 - a) the residential / farm property class I .0000
 - b) the commercial property class 1.6191
 - c) the industrial property class 1.8173
 - d) the farmland property class 0.2500
 - e) the managed forest class 0.2500
- 2. THAT any previous by-law or resolution which was passed for this purpose, or which conflicts with this by-law, be and is hereby repealed.

BY-LAW 2024 – 04

A by-law to provide remuneration for Members of Council, and to repeal By-law 2023 - 04

WHEREAS the *Municipal Act*, 2001, as amended, provides that the Council of a municipality may, by By-law, provide for remuneration and payment therefore for its officers; and

WHEREAS Section 284 (1) of the *Municipal Act*, as amended, the Council of the Corporation of The Township of Tarbutt passed By-law 2023-04 on January 18, 2023 approving the rate of Remuneration for Members of Council; and

WHEREAS Council now deems it desirous and expedient to amend the rate of Remuneration;

NOW THEREFORE the Council of the Corporation of The Township of Tarbutt enacts as follows:

- 1. Effective January 1, 2024, remuneration shall be provided as follows:
 - a) Head of Council (Mayor)

\$638.70 per month;

b) Councilors

\$529.52 per month.

- 2. Members of Council authorized to represent the Township at formal functions, meetings, seminars, conventions, etc. outside the boundaries of the municipality shall be eligible for reimbursement to a maximum of \$75.00 per day to cover expenses; \$45.00 per half day.
- 3. The remuneration provided for in this By-law shall be paid by the Treasurer of the Corporation from the funds provided by the Council.
- 4. The Treasurer shall, on or before the 31st day of March in each year, submit to the Council an itemized statement of remuneration and expenses paid to each member of Council in respect of their services as a member of Council.
- 5. Any By-law or part of a By-law conflicting with this By-law shall be hereby repealed.

THE CORPORATION OF THE TOWNSHIP OF TARBUTT BY-LAW 2024 – 05

A BY-LAW authorizing the Mayor, the Clerk, and the Community Emergency Management Coordinator to enter into an Agreement with the Treasury Board Secretariat of Ontario to provide funding for Emergency Preparedness and Community Safety.

WHEREAS pursuant to section 2 (5) subsection (3) of the *Municipal Act*, S.O. 2001, c 25, as amended, the power of the Council of the Corporation of The Township of Tarbutt shall be exercised by By-Law; and

WHEREAS Section 8 (1) of the Municipal Act, 2001, as amended, provides that the powers of a municipality under this or any other Act shall be interpreted broadly so as to confer broad authority on the municipality to enable the municipality to govern its affairs as it considers appropriate, and to enhance the municipality's ability to respond to municipal issues; and

WHEREAS Section 9 of the *Municipal Act*, 2001, as amended, grants municipalities the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under the Act; and

WHEREAS the Township has applied to the Treasury Board Secretariat for funding under the Community Emergency Preparedness Grant to provide essential equipment and supplies to increase community resiliency and preparedness, to enhance volunteerism for emergency preparedness, and to ensure the sustainability of said equipment and services; and

NOW THEREFORE BE IT RESOLVED THAT the Council of The Corporation of The Township of Tarbutt enacts as follows:

- THAT Mayor Lennox Smith, Clerk Carol Trainor, and Community Emergency Management Coordinator (CEMC) Edward Sadowski of the Corporation of The Township of Tarbutt have the authority to bind the municipality to the Province of Ontario through the Treasury Board Secretariat for the purposes of the aforementioned agreement.
- 2. THAT any previous by-law or resolution which conflicts with this by-law be hereby repealed.
- 3. THAT the Mayor, the Clerk, and the Community Emergency Management Coordinator shall have the authority and direction to execute the above noted Agreement, including any renewal agreements or administrative amendments.
- 4. THAT this Agreement shall come into force and take effect upon the signing.

That The Township of Tarbutt support the resolution from the Township of Asphodel-Norwood calling for action to reduce insurance costs to municipalities, following the trend of steadily increasing insurance rates and limited providers willing to quote on municipal insurance; and

That The Township of Tarbutt circulate a resolution objecting to the increase to the 2024 levy imposed by MPAC, given that they have been relieved of the responsibility of providing municipal enumerations services, including the creation of a Preliminary List of Electors, and will have a significant reduction in service provision and staffing requirements, and that this service will be provided at no cost by Elections Ontario; and



That The Township of Tarbutt support the letter from retired employees of Public Health Ontario cautioning the provincial government against acting on service reduction recommendations and the closure of 6 regional laboratories which service communities in 15 public health jurisdictions without fully understanding the ramifications and logistics required to deliver timely results, and to seek an up to date, independent impact assessment on the impact of these proposed reductions using a public health focus; and

That Council supports the resolution provided by AMO asking the Province of Ontario to collaborate with AMO toward a comprehensive social and economic prosperity review to promote the stability and sustainability of municipal finances across Ontario.
