1. CALL TO ORDER

6. STAFF AND COMMITTEE REPORTS

a. Roads Department and Roads Committee meeting of January 17, 2022 (verbal)

Road Superintendent Mike Pigeon discussed the potential work to be done on Creek Road to avoid the road flooding each year, pending receipt of a survey. This work will have to be contracted out as the township does not have the equipment to do the work.

The Amalgamated Tender will be confirmed at the February 8/23 East Algoma Road Super's meeting. The Roads Committee will meet with the Treasurer to confirm projects and materials to get Council approval in advance of that. The cost of culverts has increased by roughly 20%, calcium is up 10%, and surface treatment materials will be up 10%.

A verbal report on the Roads Committee meeting held Tuesday, January 17, 2022, was provided. Items discussed included a review of the year end budget to actuals, sand and salt supplies, allocation of expenses, the cascade effect of the time spent at the landfill, as well as potential projects and purchases for 2023.

The Clerk advised that J. Brice has been asked to accept the position of Training Officer with the Tarbutt Fire Department. This is a good opportunity for Mr. Brice, as well as being good for the fire department to have a dedicated training officer.
